MOST MARYLAND HEALTH CONNECTION ENROLLMENT EVENTS CONTINUING THIS WEEKEND SOME CHANGES DUE TO INCLEMENT WEATHER

BALTIMORE (Dec. 9, 2017) – Maryland Health Connection will hold "Last Chance" events this weekend to help Marylanders enroll in health coverage. Trained navigators are available to provide free help with enrollment through the state's health insurance marketplace before the deadline on Dec. 15.

Three of 18 events scheduled for today have been cancelled due to weather: at St. Mary's County Library Charlotte Hall Branch; at the Queen Anne's County Library Kent Island Branch, and Wicomico County Library in Salisbury. Hours have been extended at a Charles County event in Waldorf until 4 p.m., weather depending.

Marylanders may enroll in 2018 private health and dental plans through the website MarylandHealthConnection.gov or the Enroll MHC mobile app until Dec. 15. Those who are eligible for Medicaid or the Maryland Children's Health Program, or who have recently experienced certain qualifying life events (such as losing coverage) can enroll year-round.

At the "Last Chance" events, Marylanders can ask questions and enroll in coverage. More information is available at MarylandHealthConnection.gov/Last-Chance.

People who would like to apply should bring the following:

- Photo ID
- Social Security numbers (or document numbers for any legal immigrants who need insurance)
- Birthdates and general information about you and your family members who also are applying for health coverage
- Policy numbers for any current health insurance
- Employer and income information for everyone in your family (for example, from pay stubs, W-2 forms or wage and tax statements)
- Information about any job-related health insurance available to your family

Last year, 9 out of 10 people who enrolled through Maryland Health Connection received financial help. Marylanders who qualify for these savings may have similar or even lower costs next year.

About Maryland Health Connection: Maryland Health Connection (MHC) is the state-based marketplace for Marylanders to shop and enroll in health insurance, as well as determine eligibility for Medicaid. It is the only place where Marylanders can access financial help such as tax credits to make coverage more affordable.
